

MANDATORY WAIVER



REQUIRED FOR ALL PARTICIPANTS AND SPECTATORS WHO WILL BE ENTERING EITHER ANY OF OUR STADIUMS. PLAYERS UNDER 18 MUST HAVE THIS WAIVER COMPLETED AND SIGNED BY A PARENT OR RESPONSIBLE GUARDIAN.

THIS WAIVER IS FOR YOUR PROTECTION AND TO ENSURE THE ENJOYMENT OF ALL OUR GUESTS. PLEASE COMPLETE AND SUBMIT IT TO REGISTRATION DESK AT CHECK-IN.

AS PARTICIPANT(S), I/WE:

- A. Acknowledge that participation in laser tag and/or bubble soccer and/or Aeroball™ and/or miniature golf involves physical activity that could result in injury to the participant. The participant assumes full responsibility for any injuries or damages which may occur to or be caused by the participant in, on, or about the games' premises from whatever cause including, without limitation, the affirmative negligence of THE MILL, its owners, employees or agents, and completely releases and discharges THE MILL and all associated outlets, its and their owners, employees and agents from all claims, damages, or liabilities present or future, whether or not known or anticipated that may result from or arise out of the participant's use or intended use of the game or the premises, facilities, and equipment related thereto. The undersigned has read and understands the foregoing waiver.
- B. Agree to play or observe all games according to the rules posted and instructions given to me by any members of staff. I acknowledge that THE MILL accepts no responsibility for any act or thing done by me which is not in accordance with the rules and instructions.
- C. Accept full responsibility for the costs of any non-accidental damage to THE MILL premises, facilities, and/or equipment caused by me.
- D. Agree to inform our staff of any relevant medical condition or treatment that I have, prior to participating in any activity at THE MILL.
- E. Understand that THE MILL features activities that may be too strenuous or stressful for very young, elderly or physically- or mentally-challenged individuals.
- F. Understand that THE MILL serves food containing tree and peanut oils and gluten.
- G. Agree that my image may be used for MILL promotional purposes.
- H. Have read and agree to all the ENTRY RULES below.

RULES:

- 1. Proper attire, including shoes and shirts, must be worn at all times. We reserve the right to deny admission to or remove any person wearing attire we consider inappropriate or attire that could detract from the experience of other guests. Special events may have additional attire guidelines.
- 2. Smoking, including e-cigarettes, is prohibited in this facility and its immediate exterior areas, including the entry areas.
- 3. We reserve the right to inspect and if necessary not allow any bag, parcel or other item to be brought into this facility and to deal with any unattended objects as we consider appropriate.
- 4. Minimum age to play laser tag unaccompanied is 8. ONE parent or legal guardian may accompany a child, ages 6-7, during a laser tag game and MUST remain with that child during the ENTIRE game. Parent/guardian assumes ALL RISKS for that accompanied child AND himself/herself. Accompanying parent or guardian CANNOT play laser tag while accompanying child.
- 5. Minimum recommended age to play Bubble Soccer is 9. Maximum height/weight is 6'5"/250 lbs.
- 6. Please supervise your children at all times. Guests under 14 must be accompanied by a guest age 14 or older to enter and have a completed waiver.

THE MILL PROHIBITS:

- o Weapons of any kind or objects that appear to be weapons.
- o Alcoholic beverages or any illegal substance.
- o Recreational devices with wheels, such as skateboards, scooters, inline skates or shoes with built-in wheels.
- o Outside food or drinks, other than cakes intended for parties hosted by The Mill.
- o Pets except approved service animals. Service animals must be clearly identified as such and under the owner's control at all times on a leash or harness.
- o The sale of goods or services or the display of goods or services for sale
- o The distribution of printed or recorded materials of any kind
- o Unauthorized events, demonstrations or speeches to incite a crowd.
- o Photography, videotaping or recording of any kind for commercial purposes
- o Engaging in any unsafe act or other act that may impede operations of The Mill
